Awaiting the 5 gas monitors purchased on the grant. April is Red Card recertification month as normal. We will have 2 new red card crew members this year, Christian and Ruben will be our newest red card holders. Still working on the medical direction with the Doctor. She will not be charging us for it which is great. Will finish reading through all the paperwork before signing the agreement.

**Unfinished Business** – Proposal from edge internet discussed last month. *Robert Firth made a motion to approval the proposal as submitted, Michael Gallegos seconded, all in favor, Motion carried.*

Discussion about Derek Dulac finishing up the septic system. We are waiting for the tank and as it soon it arrives, he will complete the work in Parshall.
